"DESIGNER OF THE YEAR 2021"

Terms & Conditions

1. This contest, TFI Fashion Design Awards 2021, is organized by SS Textile Media Pvt. Ltd. # 826, 9th Cross, 10th Main, Indiranagar 2nd Stage, Bangalore – 560 038, India.
2. The TFI Fashion Design Award 2021 will be held on 2nd July 2021 at Hall No. A4bGF, Pragati Maidan, New Delhi.
3. Designers applying for the contest should be either final year students or graduates from reputed Fashion Institutes of India. Designers with no formal fashion degree but with a minimum of 3 years of work experience may also apply.
4. I/We agree to provide to TFI Fashion Design Awards the following documentation for consideration of this application at the time of submission (only in soft copies):
 - a. Biography / Profile of Designer
 - b. Typed statement on Designer's Fashion philosophy
 - c. RTW Collection of 5–8 ensembles presented with concept note (around 100 words), mood board and detailed sketches with the fabrics, trims and colours.
 - d. Photos / Portfolio of garments or accessories created in the past three years.
 - e. Written statement of Designer's capability to manufacture apparel or accessories within 60 days.
 - f. List of trusted manufacturing facilities and their contact details.
 - g. A photocopy of your identification card (valid Driver's License /PAN / Aadhar)
5. TFI Fashion Design Awards is authorized to use photos submitted with the application for any promotional purpose related to the event contemplated by this Agreement.
6. Selection of representatives/contestants entails an obligation to attend all functions and meetings organized by TFI Fashion Design Awards and at which attendance is either mandatory or specifically requested.
7. Each Designer will create ensembles only using fabrics sponsored by TFI exhibitors, effective usage of provided materials will be a key parameter for judging. TFI Fashion Design Award reserves the right, at its sole discretion, to disqualify a contestant who is in breach of not fulfilling this terms & conditions of the contest. Designer may choose to use their own fabrics / accessories only as supporting materials for creating their ensembles.
8. Materials provided by the TFI sponsor exhibitors, may belong to any of the following categories:
 - a. Dress materials (suitable for women's wear)
 - b. Shirting / Top weight materials
 - c. Suiting material / Outerwear material
 - d. Fancy / Novelty material (laces / fur / jacquards / dobby)
 - e. Bottom weight / Denim material
 - f. Assorted Trims

9. All tailoring and manufacturing cost will be borne by the finalist designers.
10. Only the airfare and accommodation expenses for the finalist designers to attend the event will be borne by TFI Fashion Design Awards. It is further understood and accepted that all the other expenses will be borne by the designers themselves.
11. It is recognized and accepted that all decisions of the panel of judges in respect of the contestants and representatives are final and there is no recourse to appeal.

Judging parameters

- a. Originality of concept
- b. Overall look/style/drape
- c. Effective usage of fabrics provided by Sponsor Exhibitor
- d. Presentation quality
- e. Quality of execution of ensembles
- f. Stage impact (ramp appeal)

12. Rewards & Recognition

- a. The winner of the title TFI “Designer of the Year 2021” will be awarded cash prize of 1,00,000/–, a trophy, and a certificate.
 - b. The first runner up of the title TFI “Designer of the Year 2021” will be awarded cash prize of 75,000/–, a trophy, and a certificate.
 - c. The second runner up the title TFI “Designer of the Year 2021” will be awarded cash prize of 50,000/–, a trophy, and a certificate.
 - d. All participants will be awarded a Trophy & Participation Certificate.
13. Prize money will be issued to the winners after deducting TDS as applicable under Income Tax rules 2020.
 14. TFI Fashion Design Awards will not be held liable for personal losses or injuries to participants, or affiliated personnel except where such loss or injury is due to gross negligence on the part of TFI Fashion Design Awards.
 15. TFI Fashion Design Awards will not be held liable for any loss of garments, accessories, supplies, tools, equipment, or personal items brought to the TFI Fashion Design Awards event by a participant.
 16. TFI Fashion Design Awards reserves the right to use all images derived in any form during or from the event/competition and to transform the same into any or all forms of media currently in existence or yet to be created.
 17. I/We agree to abide by all established times for fittings, photo shoots, bazaars, special appearances, media interviews, and shows, and to respect times allotted to prepare for subsequent shows.
 18. I/We agree to liaise in advance for the photo shoot with the assigned Producer in respect to the appropriate models, make-up and hair consultant(s) in respect of the desired make-up and hair effect to be achieved.

19. I/we agree to accept the terms of operation and compensation established by TFI Fashion Design Awards in respect to its role as Investor, venture capitalist and Collective Label Producer as disclosed and contracted with the relevant designers and disclosed to the Fashion Schools/employer of each.
20. It is understood that TFI Fashion Design Awards reserves the right to either postpone or cancel any part of the entire event/competition in its sole discretion.
21. TFI Fashion Design Award reserves the right, at its sole discretion, to disqualify any contestant that it determines to be tampering with the entry process, the operation of the contest, or to be acting in breach of the terms & conditions of the contest.
22. It is understood and accepted that TFI Fashion Design Awards reserves the right to review all designs and garments at any time prior to presentation/uploading into the online shop for public viewing in order to ensure quality and completion, and further has the right to remove any garment or design from presentation/competition if, in its sole discretion, it deems appropriate to do so. The cost for repairs and damages will be borne by the designer.
23. I/We agree to abide by the rules and regulations that refrains us from the direct sale of designs and merchandise which are exclusively under the TFI Fashion Design Awards brand to consumers during the competition. All merchandise produce should be accounted for and passed through TFI Fashion Design Awards for quality checking and monitoring. I/We agree to only endorsing orders for purchases of the TFI Fashion Design Awards labelled merchandise during the duration of the competition.
24. This Agreement, along with any other document, and in particular the General Rules or mechanics of the competition, specifically referred to or implied herein as having legal effect, shall constitute the entire agreement between the parties hereto, and each party undertakes that it has read and understood the terms of the Agreement.
25. Any right, benefit, or obligation due to a party to this Agreement cannot be assigned by either party without the prior written consent of the other.
26. All disputes, if any, arising out of/in conjunction with/as a result of the contest or otherwise shall be subject to the exclusive jurisdiction of the competent courts/tribunals in Bengaluru city only. This is irrespective of whether courts/tribunals in other areas have concurrent or similar jurisdiction.
